Dear Parent:



Your son/daughter has enrolled in the Timberlane Regional High School Snowriders Winter Sports Club.

We strive to meet reasonable safety standards in every school activity. However, we remind you that participating in any sport (such as skiing or snowboarding) has some risk of harm involved in the normal course of action.

To better inform you of the risk potential of this activity, I enclose a description that shows specific potential injuries common to these sports. Common potential injuries associated with skiing and snowboarding include, but are not limited to sprains, strains, contusions, abrasions, concussion, fractures, more serious injuries, and rarely, death.

Participation in some sports and/or activities may require that you provide evidence of medical insurance to protect you from any medical cost from injury. If student accident insurance is not purchased, any medical cost should be submitted to your family health insurer. If you do not have health insurance, you must let us know, since the district does not have insurance covering student accidents.

If your child has medical or other problems, you must relay this information to the Snowriders Club advisors as we are relying on you for this information. This information will be kept confidential.

You must understand the school cannot ensure safety for students. The school's obligation is to take reasonable precautions for safety and well-being. Accidents do occur, especially when participating in sports. In addition, your child also has a responsibility for his/her safety and the safety of others.

In order for your son/daughter to participate in the Timberlane Regional High School Snowriders Club, you must sign an agreement which gives your consent for your son/daughter to participate and acknowledge that you have been warned that there are risks of injury involved. This agreement does not preclude your son/daughter from making a claim against the school or its employees if there has been a failure to meet a reasonable standard of care that results in physical harm to your son/daughter, and the district is proven negligent.

Acknowledgment of Warning and Consent Agreement

I/We, am/are the parent(s) or guardian(s) of a Timberlane Regional High School Student, a minor, who desires to participate in the TRHS Snowriders Winter Sports Club.

I/We, acknowledge that I/We have been informed as to the nature of the sport, and that this sport has risks of injury associated for those who participate, including transportation from and to the school campus. Although the Snowriders Club advisors will endeavor to provide each participant with due care, the school cannot ensure that my/our child will remain free of injury.

I/We represent that my/our child is physically fit to participate in this sport and, if required, that he/she has been examined by a licensed physician who verifies that my/our child is physically fit to participate in the Timberlane Regional High School Snowriders Winter Sports Club. The school district will rely on this representation.

I/We understand the school cannot ensure the safety of children and that the school's obligation is to take reasonable precautions for safety and well-being. Our child also has a responsibility for his/her safety and the safety of others.

I/We acknowledge that I/We must provide the Snowriders Club advisors with any medical or other information which I/We feel is important for the school to know about our son/daughter. This information must be kept confidential. I/We will provide medical and other information on our child prior to the start of participation in these sports. The school district will rely on me/us to provide this additional information.

I/We acknowledge my/our child must adhere to all the rules, regulations, and instructions pertaining to the safety and protection of the participants, and that failure to comply could exclude my/our child from participation in these sports.

I/We acknowledge and understand the risks and requirements for our child to participate in the sports of skiing and/or snowboarding.

In consideration of the benefits to be derived, and in view of the fact that Timberlane Regional High School is an educational institution offering an after-school activity (ski/snowboarding program), participation in which is voluntary, and having full confidence that every reasonable precaution will be taken to ensure the safety and well-being of my child on this activity, I/we agree to and support his/her participation in this after-school activity (ski and snowboard program). I/We further agree to hold harmless and waive any and all claims against the leaders of this trip and officers, agents, and representatives of the Timberlane Regional High School and School District.
